

### Planners Put the Brakes on Car Collector Permit Law

After listening to complaints from angry antique car hobbyists who drove their Model Ts and vintage Rolls-Royces to a public ventage Attack of the Los Angeles city Plan-ning Commission rejected a pro-posed ordinance Thursday that would have placed restrictions and \$340 fees on owners of "historic vehicle" collections.

The measure was drafted in response to residents in the East San Fernando Valley who com-plained that collectors were turning their vards into virtual junk-

The ordinance would have forced collectors to keep their cars only in the resr portions of their property, prohibited the use of power tools and required an initial \$340 "collector's fee" as well as an annual \$100 renewal fee.

It would also have limited the number of cars collectors could-

keep on a piece of property.

About 300 enthusiasts from carclubs throughout Southern California, many wearing their club shirts, argued at a commission bearing in

### CARS: Hobbyists Prevail Over Antique Permit Plans

Continued from Page 1 Van Nuys that the proposal to regulate owners of "historic vehicles" would unfairly hurt legitimate hobbyists.

We don't like people who are slopping down cars in front lawns, messing up neighborhoods, either. said Win Burkhardt, of the Association of California Car Clubs.

But to assess everyone \$340 and then force us to store the cars in the rear portion of our property when we are conforming to neighbor-hood standards is discriminating."

The measure was drafted after the City Council asked the Planning Commission's staff to investigate complaints from a group of Sylmar residents who said a weak Municipal Code has frustrated enforcement against storage of old vehicles that look more like junk than an antique car collection.

Car collectors have cited state and city laws to defend themselves.

The state puts no limit on the number of "special interest vehicles" (defined as cars preserved in their original state and used by hobbyists) that can be kept on a piece of property as long as they do not constitute a health hazard and

are screened from public view.

The Municipal Code also allows any number of automobiles to be collected in a residential zone as long as the use is "accessory," meaning that the cars are not part of a business.

So aithough Edward Cholakian's Sylmar neighbors contend that his backvard collection of at least 30 1940 Cadillacs and other aging cars

represents a junkyard, city building inspectors have had no way to regulate the number of vehicles stored on his property because he meets existing state and local

standards.
"There are cases when we have found in excess of 100 cars, junkers. could use a building and safety code that can handle situations like

The proposed ordinance would have attempted to plug the loophole in the Municipal Code by creating a "historic vehicle collection" and defining a collector as the owner of one or more antique cars.

Besides the fees, the ordinance would have set tough restrictions on the collectors, such as a requirement that only one car could be kept on each 250 square feet of backyard property.

The collector's fee was intended to separate serious collectors of historic vehicles from those who merely intended to use their yards as storage areas, city planners said.

### Car Collecting Permit Proposal Opposed in Los Angeles

Antique auto collectors in the Los Angeles, Calif. area faced a challenge Aug. 30 when a city ordinance was proposed to severely limit the pursuit of their hobby.

The city planning commission proposal, which would set limitations on car collecting in Los Angeles, was greeted by an estimated 300 antique car owners who opposed the idea.

The ordinance would impose permit fees of \$340 plus an annual renewal of \$100, require annual inspections of the car owners' backyards, notify neigh-

tion of our property when we are conforming to neighborhood standards is discriminating."

This original plan was replaced by two less stringent proposals before the public hearing began on Aug. 30.

The commissioners rejected the original plan and sent the two alternative plans back to be worked on.

"I would say, without question, we won the day," Dr. Paul L. Kirk, president of the local chapter of the Early Ford V-8 Club, said. "It's basically back to almost square one."

Kirk, an anthropologist and car collector, attended the August Long Beach, Calif. swap meet with his wife, both of whom wore large placards reading, "L.A. City Plans to Throttle Car Collectors!" They distributed more than 500 flyers which spelled out the new curbs sought by the commissioners, as well as information on the hearing.

Kirk told the commission the annual backyard inspections would constitute a "spy policy," and notifying neighbors of the proximity of a car collector amounts to "an encouragement to fuss."

The proposed minimum permit fees of \$340 and a \$100 annual renewal for ownership of one of more cars more than 25 years old also appeared unpopular with the commission.

"We don't have to get permits and pay fees any more than one would for stamp collecting," Kirk said.

The commission did not vote formally on the issue, however, which means that there is still a possibility a new plan will be drawn up at some future date.

The California Vehicle Code allows outdoor storage of historic automobiles if the storage areas are hidden from public view and do not constitute a health hazard.
