## **INSURANCE**

As an official Regional Group of the Early Ford V8 Club of America, you are covered under a blanket insurance policy carried by the National organization. What follows is an outline of the Club's current insurance policy.

It should be noted that the <u>By-Laws of the National</u> constitution requires all chapter members to be members of the

Early Ford V8 National Organization.

#### WHERE

Members are covered in all locations in the United States of America, its territories, possessions or Canada. At this time, foreign chapters are not covered under the National policy. They should seek local coverage in their respective nations.

#### WHO IS INSURED

All members, officers and directors with respect to their liability while performing any activities on behalf of the club. This also means those acting on behalf of regions and chapters.

Activities do not have to be "officially" authorized.

Regional group officials are included as are national. It is not necessary for domestic chapters to carry separate public liability insurance.

#### WHAT THEY AND THE CLUB ARE INSURED FOR

They are insured for occurrences that may happen on any club property which is rented, leased or used by the club for activities which the club may participate in. This includes but is not limited to meetings, dances, tours, picnics, flea markets, banquets, shows, shopping centers, also offices used by the club.

All <u>free</u> meeting places are covered. The important factor is that the meeting place cannot be <u>owned</u> by the organization.

<u>PRODUCTS LIABILITY</u> of the club, which includes dispensing of food at these events or selling or giving away products such as articles of clothing, jewelry, toys, etc.

PERSONAL INJURY LIABILITY arising out of an offense such as libel, slander or defamation of character by an officer, director or member while acting on behalf of the club.

NON-OWNERSHIP AUTOMOBILE LIABILITY which means if someone is using his own automobile whether antique or modern for club activities and he is involved in an accident, the company will pay up to the limits of the policy or defend the club and all members involved in the occurrence as excess xoverage over any other valid and collectible insurance.

ADVERTISING OFFENSES LIABILITY that protects the club, its regional groups and chapters for all the magazines published by the clubs for libelous statements made in these magazines.

HOST LIQUOR LAW LIABILITY that protects the club if someone gets intoxicated at a club event from serving or giving alcoholic beverages and the person injures someone in his car or otherwise. This could be a member or guest who becomes intoxicated after being served at a club function and causes an accident.

Liquor law liability is somewhat more complex due to varying and frequent judicial decisions and jurisdictions. The coverage, as presently written, would cover this provided that the Regional group/chapter does  $\underline{NOI}$  engage in liquor SALES.

CONTRACTUAL LIABILITY that means if the club rents an area, such as for a show, they will assume the liability of the people they rent from and the insurance company will automatically protect the club from any liability. It is common practice to pass off liability to the people renting or using other people's property.

NON-OWNED WATERCRAFT LIABILITY that protects the club from any suits that are brought as a result of any accidents that occur during an event when they hire a boat for outings (under 26 feet in length). For watercraft over 26 feet in length, the event chairman should contact the National Club's insurance representative in advance of hiring so he can arrange the carrier extend coverage for it.

CERTIFICATE OF INSURANCE - Often a Certificate of Insurance will be required from a Regional group/Chapter when participating in an event in a public or private place. If such a certificate is required, contact the Club's Insurance representative well in advance of the event so such a certificate can be issued.

The club may participate in any activity which a club usually does whether it is a commercial enterprise for a fee like charging admission to enter a flea market or show or whether it is free.

If there is going to be a grandstand involved, the company should be notified ahead of time so they can make a proper

inspection.

When Regions or chapters, in order to raise money, organize a group of antique cars to give people rides and charge a fee, we will protect the club but NOT the individual who owns the car. There is a definite exclusion on the car policy when a fee is charged. This practice should be completely discouraged.

Events such as parades sponsored or alleged to be sponsored by the club are covered for liability both <u>BODILY INJURY</u> and <u>PROPERTY DAMAGE</u>. If in a parade, tour, etc., a car is involved in an accident and someone is injured, the attorney for the injured party will bring suit against <u>all</u> parties involved. The insurance club will defend "<u>The Club</u>" and pay whatever the judgement amount may be up to the policy limits.

One could use many examples, however it is clear that activities which the club generally participates in will ordinarily be covered for liability. Any questions should be brought forward and directed to:

This brief summary may bring up additional questions as

there are surely those that cannot be answered here.

Mr. Breuer's office will be pleased to reply to further questions. You should not consider this brief review as a complete description of the National Early Ford V8 Club's insurance policy.

This summary has been an attempt to outline answering questions most frequently asked in simple non-legal words. However, a narrative description can never replace the policy itself and the actual policy language will govern the scope and limits of coverage involved.




